TERMS AND CONDITIONS

- 1. Participation is for children 16 years and under.
- 2. Performances will be split into (Under 12) and (12 years to 16 years).
- 3. Applicable to Local Schools and Talent Schools in the local area.
- 4. Applicable to parents' children participation that are members of Regent St Pavilion in the local area of Regents Park.
- 5. Heat 1, Heat 2, Semi Final and Grand Final will be held at Regent St Pavilion.
- 6. Heat #1 Monday, 14 April, 5.00pm to 8.00pm (up to 12 performances) Heat #2 – Tuesday, 15 April, 5.00pm to 8.00pm (up 12 performances) Semi Final – Wednesday, 23 April, 7.00pm to 9.00pm (up to 18 performances) 6:00pm to 9:00pm (up to 12 performances). Grand Final – Saturday, 26 April, 6:30pm to 9:00pm (12 finalists doing a performance each) 6.00pm to 9.00pm (6 finalists performing 2 acts each).
- 7. To be a contestant participants must complete an online registration form visit: DOOLEYS.COM/REGENTSTPAVILION.
- 8. Registration ends Friday 11 April 2025.
- 9. To be a contestant, entrants are required to fill in the registration form which will reach the Entertainment Consultant. Contestants will then participate in a heat for their chance to move onto the Semi Final then Grand Final for their chance to win the major prize.
- 10. Participants can perform any type of act, including but not limited to, singing, dancing, comedy, acting magic or another talent.
- 11. Participants can participate as soloists, duos or in a group.
- 12. Participants may perform the same act in the heats and Semi Finals. On the Grand Final they will perform two new acts. All acts must be within the same category of talent.
- 13. To participate, the performer/s must pay the registration fee of \$10 per Act, before Heat 1, by Friday 11 April 2025.
- 14. \$10 registration fee applies as soon as you complete the registration form.
- 15. First prize is \$1600, second prize is \$500, and third prize is \$200.
- 16. You must provide a good quality backing USB and is to be no longer than 4 minutes.
- 17. You will be notified of your heat date by the Entertainment Consultant.
- 18. Regent St Pavilion reserves the right to refuse entry to any persons at any time.
- 19. Homegrown Stars takes no responsibility for any loss or damage to any costumes or props belonging to participants.
- 20. Participants will be assessed by the judging panel with a set of criteria such as for example: presentation, technique, audience response, audience engagement etc.



- 21. Judge's decision is final. No correspondence will be entered into. Entrants agree to abide by judge's decisions. It will be judging by professional artists.
- 22. Participants in heat 1, heat 2 please arrive 30 minutes prior to the start of the event for check off.
- 23. Parents of the Semi Final and Grand final contestants will receive a confirmation email by the Entertainment Consultant also advising the time of arrival.
